





# **Call for Applications**

DIL Explore (Spring 2014)

Release Date: February 1, 2014

Deadline: March 20, 2014 at 11:59 pm Pacific Time

The Development Impact Lab (DIL) invites its affiliates to apply for small grants (up to US \$5,000) to support:

- Early-stage, exploratory research that combines technology innovation with social and economic research to solve international development challenges (i.e., the emerging field of <u>development</u> <u>engineering</u>); and/or
- **International travel to developing countries** that supports *development engineering* projects through research, fact-finding or new partnerships.

**Applicant Eligibility**: This funding opportunity can be used to support graduate students, postdocs, and other researchers working with Principal Investigators (PIs) at DIL-affiliated centers and insitutions<sup>1</sup>. The latter includes, but is not limited to, the majority of faculty affiliated with the University of California, Berkeley.

**Geographic Focus Eligibility:** Projects must focus on issues relevant to one or more eligible developing countries. Below is a list of eligible countries where DIL or its partner organizations have previously supported projects. *Additional focus regions that are not included in this list may in many cases also be allowable*, but please contact dil-grants@berkeley.edu to confirm eligibility as soon as possible and before submitting an application for an unlisted country.

DIL Explore (Spring 2014)

**Background**: DIL is a USAID-funded research network fostering the design, rigorous testing, and scale-up of technological solutions for international development. DIL also aims to establish a new discipline, *Development Engineering* (Dev Eng), which addresses poverty by integrating science and engineering advances with economic and social innovation. Dev Eng will formalize the iterative design of technologies for low-resource communities, using insights from social science and development economics to drive innovation. It will also result in new tools for measuring the adoption and impacts of anti-poverty interventions, including sensors, mobiles, and other devices for data collection.

DIL Explore grants are intended to support preliminary research as well as international travel to develop a new idea or establish partnerships. Grant winners are encouraged to apply for follow-on support through DIL's larger, semi-annual grant program, DIL Innovate (with awards of up to \$200,000). The next DIL Innovate application round is planned for Fall 2014. More information can be found at: dil.berkeley.edu/technology-portfolio/competitions-incentives

**Review Criteria**: Successful applications to DIL Explore will clearly advance the nascent field of development engineering, by **combining techniques and insights from social science with advances in engineering and the natural sciences**. In general, DIL does not fund projects that focus exclusively on technology design, prototyping, or modeling without consideration of the social, economic, and institutional factors that affect technology adoption. Similarly, DIL does not generally fund projects that lack a technological innovation (e.g. we would not fund routine application of existing mobile technologies).

Applications will be evaluated for relevance, novelty, and potential impact. Requests will also be evaluated for the immediate value that the DIL Explore grant will have on the project, e.g. through fostering new international partnerships in low- and middle-income countries, collection of baseline data, or testing of an initial hypothesis.

1 Applicants must have Principal Investigator (PI) status at a DIL-affiliated center or institute. Eligible PIs include those appointed at the University of California, Berkeley; the Blum Center for Developing Economies (with sites across the University of California); the Center for Effective Global Action (CEGA); Technology and Infrastructure for Emerging Regions (TIER) and the Mezuri Group; Policy Design and Evaluation Lab (PDEL) at the University of California, San Diego; the LBNL Institute for Globally Transformative Technologies (LIGTT); Centre for Technology Alternatives for Rural Areas (CTARA) at IIT Bombay; Global Change Programme at Jadavpur University; and select Colleges at Makerere University. Select non-affiliated researchers who have been notified of their eligibility may also submit applications. Note that funds may be used to support faculty-mentored students or collaborators beyond the immediate DIL network.

**Budget:** Requests of up to US \$5,000 in direct costs are permitted. Allowable line items include air tickets on U.S. air carriers, lodging, ground transport, meals & incidental expenses, and research supplies. No other items are allowed.

**Restrictions**: It is not permissible to purchase a laptop using this grant. Requests for lodging or meals &Incidental Expenses (M&IE) may not exceed rates published by the State Department Office of Allowances, available online at <a href="http://aoprals.state.gov/content.asp?content\_id=184&menu\_id=78">http://aoprals.state.gov/content.asp?content\_id=184&menu\_id=78</a>. All travel must comply with the Fly America Act. If you expect other classes of expenses that are not listed above, but may be critical for your research, please contact <a href="mailto:dil-grants@berkeley.edu">dil-grants@berkeley.edu</a> prior to submitting your application.

Note that all travel and related project costs with the possible exception of flights are expected to be purchased directly by the traveler; expenses will be reimbursed by UC Berkeley following the completion of travel. DIL Explore grant recipients will also be asked to provide travel information to be submitted to USAID prior to travel, e.g. dates of travel and IRB approval/exemption status (as needed).
